- (b) possessing the following educational qualifications, namely;

Essential:

Degree in Architecture or Town Planning or equivalent from a recognized university;

Desirable:

- (a) fifteen years' experience in Town Planning/ Architecture in local bodies/townships;
- (b) good knowledge of Delhi's building bye-laws;
- (c) original work done in the field of Town Planning.

Note 1: A departmental candidate in the feeder grade of Assistant Secretary (Technical) in Pay Band of Rs. 15,600-39,100/- with Grade Pay of Rs. 6,600/- with 10 years regular service in the grade shall also be eligible to be considered for this post along with the outsiders and in case he is selected, his appointment shall be deemed to have been made by promotion.

3. **General Conditions**
