## MEMORANDUM

## Sub: Online submission of proposals to the Delhi Urban Art Commission.

In terms of the Government of India's policy of Ease of Doing Business the Commission has already switched over to the system of online submission of proposals. The Commission at its meeting held on April 12, 2017 had decided that it shall accept only such online proposals which are being referred through the concerned local bodies with due certification from regulatory provisions point of view failing which the office of the Commission will reject and return the proposal without consideration by the Commission. However, proposal referred direct to the Commission for conceptual consideration shall continue to be accepted. A memorandum no.43(5)/2014-DUAC dated April 25, 2017 was accordingly issued to the local bodies and all concerned.

The Commission reviewed the position at its meeting held on 30.08.2017 and it was observed that most of the proposals being received by it are offline. Only a few proposals are being received online.

The Commission decided to write to all the local bodies that w.e.f. November 1, 2017 the local bodies will be required to send all the proposals online only and the Commission will not be in a position to accept the proposals offline any more.
