## **MEMORANDUM**

Sub: Forwarding of online proposals to the Delhi Urban Art Commission by the Local Bodies.

The above matter was considered by the Commission at its 1422<sup>nd</sup> meeting held on April 12, 2017 in which the Commission observed as follows:-

"In terms of the Government of India's policy of *Ease of Doing Business*, the Commission has switched over to the system of online submission of proposals. It is however, observed that proposals are being referred online directly by the project proponents/architects to the DUAC without certification/checking by the local bodies from the regulatory provisions point of view which is not in consonance with the provisions of Section 12 of Delhi Urban Art Commission Act, 1973 (1 of 1974) which is reproduced below:

"Notwithstanding anything contained in any other law for the time being in force, every local body shall, before according approval in respect of any building operations, engineering operations or development proposals referred to in sub-section (1) of section 11 or intended to be undertaken in any area or locality specified in sub-section (2) of that section, refer the same to the Commission for scrutiny and the decision of the Commission in respect thereof shall be binding on such local body."

Accordingly, the Commission decided that henceforth it shall accept only such online proposals which are being referred through the concerned local bodies with due certification from regulatory provisions point of view failing which the office of the Commission will reject and return the proposal without consideration by the Commission. However, proposal referred direct to the Commission for conceptual consideration shall continue to be accepted.
