ORDER OF APPELLATE AUTHORITY

An online Appeal RTI Appeal registration No: DUACO/A/E/20/00003 dated 05.08.2020 filed by Shri Pushpendra Singh, Village-Pachwas, Post-Pachwas, District-Basti, Uttar Pradesh-272127 against the decision dated 05.08.2020 given by Sh. Rajeev Kumar Gaur, Assistant Secretary (I) & CPIO, DUAC, New Delhi.

On an online application (RTI request registration no: DUACO/R/E/20/00015 dated 13.07.2020) by Shri Pushpendra Singh under Section 19(1) of the Right to Information Act, 2005. In exercise of the powers, conferred upon the Appellate Authority by Section 19(6) of Right to Information Act, 2005, the Appellate Authority makes the following order:

1. Shri Pushpendra Singh has filed an online RTI application RTI request registration no: DUACO/R/E/20/00015 dated 13.07.2020 under the Right to information Act, 2005 seeking the following information:
 - a. *Recently DUAC released a vacancy circular for 1 post of Lower Division Clerk by Direct Recruitment. The application was invited in offline mode. More than 6 months have passed but until now we have not received any information regarding the exam. Sir, even after 6 months we do not know that whether our form was accepted or not. Under the RTI Act, 2005, I request you to please provide following information: Details about our application form that whether it was selected or not, if possible complete list of candidates whose forms has been accepted, expected date of conduct of exam and syllabus of exam.*
 - a. Sh. Rajeev Kumar Gaur, Assistant Secretary (I) & CPIO, DUAC vide letter no: 47(19)/2020-RTI Cell dated 04.08.2020 had given the following reply electronically on 05.08.2020 to Shri Pushpendra Singh within the stipulated time limit:
 - *The applications received are being scrutinised from admissibility point of view. Date of examination etc. is yet to be decided.*
 - b. Since Shri Pushpendra Singh was not satisfied with the reply given by Sh. Rajeev Kumar Gaur, Assistant Secretary (I) & CPIO related to the query of his online RTI application dated 13.07.2020, he has filed an appeal before the Appellate Authority and requested for the required documents and information to the Appellant immediately without further delay.
