## ORDER OF APPELLATE AUTHORITY

An Appeal RTI Appeal no: DUACO/A/E/22/00001 dated 31.01.2022 filed by Shri Ajay Sharma, फ्लैट न0 सी-5/128, Milan Vihar Cooperative Group Housing Society Limited, 72, IP Extension, Delhi-110092 against the decision dated 18.01.2022 given by Smt. Alka Dhir, Private Secretary & CPIO, DUAC, New Delhi.

On an RTI application filed by Shri Ajay Sharma under Section 19(1) of the Right to Information Act, 2005. In exercise of the powers, conferred upon the Appellate Authority by Section 19(6) of Right to Information Act, 2005, the Appellate Authority makes the following order:

1. Shri Ajay Sharma has filed an RTI application No. DUACO/R/E/21/00029 dated 22.12.2021 under the Right to information Act, 2005 seeking the following information:
  - "1. Complete Approved Sanctioned Plan by Delhi Urban Arts Commission in respect of MILAN VIHAR COOPERATIVE GROUP HOUSING SOCIETY LIMITED, 72, IP EXTENSION, DELHI-110092.
  2. Approved Lay-out Plan indicating the towers and green open area including roads by Delhi Urban Arts Commission of the MILAN VIHAR COOPERATIVE GROUP HOUSING SOCIETY LIMITED, 72, IP EXTENSION, DELHI-110092.
  3. Approved Complete Floor-Plan indicating open area and lift area, etc. (by Delhi Urban Arts Commission) of all the towers of the MILAN VIHAR COOPERATIVE GROUP HOUSING SOCIETY LIMITED, 72, IP EXTENSION, DELHI-110092."
- a. Smt. Alka Dhir, Private Secretary & CPIO, DUAC vide letter no: 47(92)/2021-RTI Cell dated 18.01.2022 had given the following reply to Shri Ajay Sharma.

"The information cannot be revealed under section:- 8(1)(d) and 8(1)(e) of RTI Act 2005 due to intellectual property & fiduciary relationship issues respectively."
- Since Shri Ajay Sharma was not satisfied with the reply given by Smt. Alka Dhir, Private Secretary & CPIO related to the query of his RTI application No. DUACO/R/E/21/00029, he has filed an appeal dated 31.01.2022 before the Appellate Authority.

## ORDER OF APPELLATE AUTHORITY

1. The original application of the applicant and the reply from CPIO has been carefully examined from the concerned RTI file. I am of the opinion that the information provided by Smt. Alka Dhir, Private Secretary & CPIO is in order.
2. The appeal stands disposed of.
