ORDER OF APPELLATE AUTHORITY

An Appeal RTI Appeal no: DUACO/A/E/22/00004 dated 09.06.2022 filed by Shri Sunil Sharma against the decision dated 12.04.2022 given by Smt. Alka Dhir, Private Secretary & CPIO, DUAC, New Delhi.

On an RTI application filed by Shri Sunil Sharma under Section 19(1) of the Right to Information Act, 2005. In exercise of the powers, conferred upon the Appellate Authority by Section 19(6) of Right to Information Act, 2005, the Appellate Authority makes the following order:

1. Shri Sunil Sharma has filed an RTI application No. DUACO/R/E/22/00004 dated 12.04.2022 under the Right to information Act, 2005 seeking the following information:

"Kindly provide an attested true copy of the layout plan and landscape plan sanctioned by Delhi Urban Arts Commission to National Building Construction Corporation Ltd (NBCC) and Ministry of Housing and Urban Affairs, Government of India regarding redevelopment of East Kidwai Nagar, New Delhi."

- a. Smt. Alka Dhir, Private Secretary & CPIO, DUAC vide letter no. 47(2)/2022-RTI Cell dated 11.05.2022 had given the following reply to Shri Sunil Sharma within the stipulated time limit.

"The information cannot be revealed under section:-8(1)(d) and 8(1)(e)of RTI Act 2005 due to intellectual property & fiduciary relationship issues respectively."

- b. Since Shri Sunil Sharma was not satisfied with the reply given by Smt. Alka Dhir, Private Secretary & CPIO related to the query of his RTI application No. DUACO/R/E/22/00004 dated 12/04/2022, he has filed an appeal dated 09.06.2022 before the Appellate Authority.

ORDER OF APPELLATE AUTHORITY

1. The original application of the applicant and the reply from CPIO has been carefully examined from the concerned RTI file. I am of the opinion that the information provided by Smt. Alka Dhir, Private Secretary & CPIO is in order.
2. The appeal stands disposed of.
