## ORDER OF APPELLATE AUTHORITY

An Appeal RTI Appeal no: DUACO/A/E/22/00005 dated 21.06.2022 filed by Shri Sunil Gandhi against the decision dated 15.06.2022 given by Smt. Alka Dhir, Private Secretary & CPIO, DUAC, New Delhi.

On an RTI application filed by Shri Sunil Gandhi under Section 19(1) of the Right to Information Act, 2005. In exercise of the powers, conferred upon the Appellate Authority by Section 19(6) of Right to Information Act, 2005, the Appellate Authority makes the following order:

1. Shri Sunil Gandhi has filed an RTI application No. DUACO/R/E/22/00006 dated 16.05.2022 under the Right to information Act, 2005 seeking the following information:

- "1. Provide a complete set of copies of the Sanctioned Plan Drawings for the property/building situated at the above mentioned address.
2. Provide a complete set of copies of the Completion Drawings of the property/building situated at the above mentioned address."

- a. Smt. Alka Dhir, Private Secretary & CPIO, DUAC vide letter no. 47(6)/2022-RTI Cell dated 15.06.2022 had given the following reply to Shri Sunil Gandhi within the stipulated time limit.

"The information cannot be revealed under section:- 8(1)(d) and 8(1)(e) of RTI Act 2005 due to intellectual property & fiduciary relationship issues respectively."

- b. Since Shri Sunil Gandhi was not satisfied with the reply given by Smt. Alka Dhir, Private Secretary & CPIO related to the query of his RTI application No. DUACO/R/E/22/00006 dated 15/06/2022, he has filed an appeal dated 21.06.2022 before the Appellate Authority.

## ORDER OF APPELLATE AUTHORITY

1. The original application of the applicant and the reply from CPIO has been carefully examined from the concerned RTI file. I am of the opinion that the information provided by Smt. Alka Dhir, Private Secretary & CPIO is in order.
2. The appeal stands disposed of.
