ORDER OF APPELLATE AUTHORITY

An Appeal RTI Appeal no: nil dated 16.04.2022 filed by Shri Nishant Rai, Advocate, 403, Nilgiri Apartments, Barakhamba Road, New Delhi-110001 received in this office on 22.04.2022 against the decision dated 06.04.2022 given by Smt. Alka Dhir, Private Secretary & CPIO, DUAC, New Delhi.

On an RTI application filed by Shri Nishant Rai under Section 19(1) of the Right to Information Act, 2005. In exercise of the powers, conferred upon the Appellate Authority by Section 19(6) of Right to Information Act, 2005, the Appellate Authority makes the following order:

1. Shri Nishant Rai has filed an RTI application No.nil dated 11.03.2022 under the Right to information Act, 2005 seeking the following information:
 1. "Provide copy of approved letter with observations dated 03-10-2018 for Layout and building plans in respect of Add./Alt. in Sadbhawna CGHS Ltd., plot No.11, Sector-11, Dwarka, Delhi-110075.
 2. Provide copy of Layout and building plans provided to Delhi Urban Art Commission along with the application copy/online request copy."

- a. Smt. Alka Dhir, Private Secretary & CPIO, DUAC vide letter no: 47(107)/2022-RTI Cell dated 06.04.2022 had given the following reply to Shri Nishant Rai within the stipulated time limit.

"Minutes of the meeting are available on DUAC website at www.duac.org.in.

"The information cannot be revealed under section:- 8(1)(d) and 8(1)(e) of RTI Act 2005 due to intellectual property & fiduciary relationship issues respectively."

- b. Since Shri Nishant Rai was not satisfied with the reply given by Smt. Alka Dhir, Private Secretary & CPIO related to the query of his RTI application No. nil, he has filed an appeal dated 16.04.2022 which is received in this office on 22.04.2022 before the Appellate Authority.

ORDER OF APPELLATE AUTHORITY

1. The original application of the applicant and the reply from CPIO has been carefully examined from the concerned RTI file. I am of the opinion that the information provided by Smt. Alka Dhir, Private Secretary & CPIO is in order.
2. The appeal stands disposed of.
