ORDER OF APPELLATE AUTHORITY

An online Appeal RTI Appeal registration No: DUACO/A/E/20/00002 dated 05.08.2020 filed by Shri Rajeev Suri, D-68 Defence Colony New Delhi-110024 against the decision dated 05.08.2020 given by Sh. Rajeev Kumar Gaur, Assistant Secretary (T) & CPIO, DUAC, New Delhi.

On an online application (RTI request registration no: DUACO/R/E/20/00014 dated 09.07.2020) by Shri Rajeev Suri under Section 19(1) of the Right to Information Act, 2005. In exercise of the powers, conferred upon the Appellate Authority by Section 19(6) of Right to Information Act, 2005, the Appellate Authority makes the following order:

1. Shri Rajeev Suri has filed an online RTI application RTI request registration no: DUACO/R/E/20/00014 dated 09.07.2020 under the Right to information Act, 2005 seeking the following information:

- a. Please provide me minutes of meeting held by DUAC on 1st July 2020 regarding approval granted to New Parliament Building to project proponent CPWD.
- b. Please provide me full details of suggested multi-level parking by DUAC to NDMC in vicinity of Parliament Building. Has DUAC proposed an underground or over ground parking lot.
- c. Please provide full details of hardscape and softscape landscape suggested by DUAC to the project proponent CPWD.

- a. Sh. Rajeev Kumar Gaur, Assistant Secretary (T) & CPIO, DUAC vide letter no: 47(18)/2020-RTI Cell dated 05.08.2020 had given the following reply electronically to Shri Rajeev Suri within the stipulated time limit:
