ORDER OF APPELLATE AUTHORITY

An online Appeal RTI Appeal registration No: DUACO/A/E/20/00004 dated 05.08.2020 filed by Shri Rajeev Suri, D-68 Defence Colony New Delhi-110024 against the decision dated 22.07.2020 given by Sh. Rajeev Kumar Gaur, Assistant Secretary (T) & CPIO, DUAC, New Delhi.

On an online application (RTI request registration no: DUACO/R/E/20/00013 dated 28.06.2020) by Shri Rajeev Suri under Section 19(1) of the Right to Information Act, 2005. In exercise of the powers, conferred upon the Appellate Authority by Section 19(6) of Right to Information Act, 2005, the Appellate Authority makes the following order:

1. Shri Rajeev Suri has filed an online RTI application RTI request registration no: DUACO/R/E/20/00013 dated 28.06.2020 under the Right to information Act, 2005 seeking the following information:
 - a. Please provide full details of approval sought by CPWD/ Architecture firm HCP Designs P Ltd. from DUAC on architecture plans for New Parliament Building, submitted by Project Proponent CPWD.
 - b. Please provide all permissions / rejections/ alterations given by DUAC on any matter related to New Parliament Building sought by CPWD/HCP Designs P Ltd. from yourselves with regard proposed New Parliament Building plans on Sansad Marg.
 - c. Please provide me copies of all such correspondence on payment basis.
- a. Sh. Rajeev Kumar Gaur, Assistant Secretary (T) & CPIO, DUAC vide letter no: 47(16)/2020-RTI Cell dated 22.07.2020 had given the following reply electronically to Shri Rajeev Suri within the stipulated time limit:
