sir we understand that architect Mr Pradeep Sharma had directly submitted online a proposal in respect of the proposed addition/alteration in the building plan for commerce complex (Square One Mall) on plot c 2 at district center saket, New Delhi. we also understand that the commission in its meeting of 14/1/21 had not accepted the proposal and made certain observations for compliance. it has also been informed to us that DUAC had accepted the proposal with certain conditions which was conveyed to the architect online on 19/4/21. Among other observations DUAC had observed that the parking provisions shall be compulsorily provided in the premises itself and adhere to the applicable regulatory guidelines in the area. the architect was conveyed vide letter of 14-15/1/21 for consideration of the commission.
