Subject: Proposal for treating Delhi International Airport Ltd(DIAL) as a Local Body.

Sir,

The GMR has vide their letter No. DIAL/2020-21/CR/752 dated 06.01.2021 (copy enclosed) sent a proposal for treating DIAL, a joint venture company of the AAI as a Local Body. In support of their proposal they have vide their letter dated 06.01.2021 quoted from the AAI Amendment Act, 2003 which authorised DIAL to sanction proposals of the AAI.

They have also attached the opinion expressed by a retired Supreme Court judge in support of their proposal. They have also mentioned about an agreement between the DIAL and Govt. Of NCT D who have assigned DIAL sole responsibility for clearances of proposals.

Clause 2(g) of the DUAC Act, 1973 stipulates the definition of local body as follows :

"local body" means the Delhi Municipal Corporation established under the Delhi Municipal Corporation Act, 1957, the New Delhi Municipal Committee constituted under the Punjab Municipal Act, 1911 as in force in Delhi, the Delhi Development Authority constituted under the Delhi Development Act, 1957, or any other local authority concerned with urban development of Delhi;

The matter was taken up with the AAI vide our letter dated 16.10.2020(copy enclosed) on an earlier reference dated 01.10.2020 from M/s GMR on the subject, for clarifying whether DIAL is being assigned functions of AAI as local body for sanctioning of development proposals / NOC from external agencies. However, response of AAI is yet to be received.

Accordingly, the Ministry is requested to advise whether DIAL can be treated as a Local Body by the DUAC in terms of section 2(g) of the DUAC Act in accordance with the policy on 'Ease of Doing Business'.
