Chapter I

Cityscape

Delhi's changing cityscape over the years is a reflection of the city's changing requirements and aspirations. In the 1970s when the Delhi Urban Art Commission was constituted, the predominant concern was about uncontrolled high-rise development, in the 1980s issues linked with Asiad, in the Nineteen Nineties the building of Dwarka and the freezing of the New Delhi Bungalow area. The main concerns of the new Millennium are: the threats to the remaining open space and protection of the City's heritage, river and forest; ecology, climate change, energy consumption, sustainability are now more pressing concerns.

In a situation where there are many players, addressing urban issues related to the city in its entirety is now crucial and there is an urgent need to have a defined vision for the future of the City.

With several mega projects under implementation by different authorities, the Commission's role is more challenging now in taking a holistic view of larger urban issues and to focus its attention on proposals for significant sites which have impact on urban aesthetic, skyline and quality of surrounding environment.

The Delhi Urban Art Commission (DUAC) with its rich experience of having considered over 8000 proposals referred over the years and conducting in-house large number of site-specific urban design studies, has been playing a vital role in enhancing the cityscape by significant value addition to the proposals considered by it.

Functions of DUAC

Apart from its regulatory functions the Commission also focuses on planning and policy formulation at city level. The functions of the Commission can be categorized as follows: -

- Recommendation on the proposals referred by local bodies and architects.
- Suo Motu initiatives to develop site specific concept design proposals on a three dimensional basic.
- Guidelines on significant policy issues referred to the Commission.

(A) Regulatory Function

The criteria for project assessment and approval developed by the Commission, on the basis of which the referred proposals are considered could be perused at Annexure I. These have also been uploaded on the DUAC website (www.duac.org.in). These criteria on Project Assessment and Approval have been introduced with the objective of avoiding subjectivity while scrutinizing projects which are referred to DUAC for approval. Special care was taken in respect of proposals which had monuments, heritage structures and large number of trees on the site.

In terms of the Unified Building Byelaws for Delhi, 2016 (UBBL) external agencies including DUAC are required to communicate their decision on referred proposals within 15 days to the concerned local body failing which it is treated as deemed approval on the proposal. In view of the aforesaid provision in the UBBL the Commission, despite the mandatory requirement that the Commission meets every twenty days, Chairman and Members appointed on a part-time basis, meet at least once every week to prevent cases of deemed approval on proposals referred to it.

The meetings of the Commission were held in hybrid form. During the year 2022-23 the Commission met 54 number of times against the mandatory nineteen meetings in a year. The decisions on proposals were promptly uploaded on the DUAC website together with Action Taken Report thereon.

Main Concern of DUAC on referred proposals

Conservation of Green Spaces: The Commission has been facing a big challenge in balancing development and preservation. Each mega project brought before the Commission is examined in the light of its impact on the existing green cover and on the surrounding areas. By modifying the layout, design etc. without compromising on the functional aspects, the Commission has been able to save large number of existing trees at the site which were initially intended to be cut.

Energy Conservation: The Commission continues to promote the policy of the Government for energy conservation. While discouraging use of curtain glass it has been recommending changes in design for creating energy efficient buildings which would depend more on natural means of lighting and ventilation rather than using artificial means for this purpose.

Parking and congestion: Due to increase in private vehicle ownership, lack of last-mile-connectivity and limited space, parking is one of the biggest challenges for Delhi. The existing infrastructure is also saturating fast thus leading to congestion in most parts, insufficient parking spaces,

encroachment of public spaces etc. The Commission has been accordingly looking closely at the circulation pattern and unhindered movement of vehicles, adequacy of internal parking so that parking does not spill over to adjacent areas.

(B) Suo Motu initiatives

The Delhi Urban Art Commission initiated several years back site-specific urban design studies with the approval of the Government. The objective was not to step on to the turf of other authorities but to demonstrate urban design schemes in a three-dimensional format, with comprehensive design proposals taking into account physical, social and sustainable aspects, which can then be taken forward by various public organizations for implementation. Many of these studies were initiated at the behest of the concerned local bodies and local authorities like the NDMC, the DDA, the Delhi Traffic Police and Rajghat Samiti etc.

The studies done have helped in promoting Government's flagship policies like the Swachh Bharat Abhiyan through the Smart toilets designed by DUAC and installed by the local authorities in different parts of Delhi. In consonance with the policy on Ease of doing Business, the user-friendly Unified Building Byelaws for Delhi were prepared jointly with the DDA and notified by the Government in 2016. The various site-specific urban design studies and guidelines on important urban aspects were conducted, which can play vital role in promotion and development of Smart Cities in the Country.

(C) Guidelines on significant policy issues

Under the generic heads 'Vision for Delhi', the Commission has prepared guidelines on significant aspects of Cityscape which would complement the development of Smart cities and are expected to enhance the

environmental quality, aesthetics of the Capital City. These guidelines having universal applicability could be adopted by the other metropolitan cities in the Country. Some of the significant guidelines are enumerated below

- Review of Master Plan 2021 for State Bhawans/State Guest Houses
- Street Design Guidelines for Delhi
- Design manual for street elements and amenities
- Design based parking recommendations for Green Park Area
- Guidelines for vehicular parking for educational institutions
- Park Design Guidelines.
- Innovative uses of urban derelict spaces and screening of urban utilities
- Dynamic Parking Norms for Delhi – 2021

The Commission looks forward to functioning in consonance with the various local bodies and authorities to promote Delhi to a world class stature.

Chapter II

Significant Proposals

The Commission had the opportunity to consider several mega projects during the year 2022-23. Each such project was examined keeping in view the Master Plan for the entire Complex, the Criteria for Project Assessment and Approval developed by the DUAC; its impact on the surrounding urban fabric and on the skyline etc. Close interaction was held with the project proponent/architect wherever required for bringing about improvements.

The significant proposals considered by the Commission during the year are mentioned below.

Building plans proposal for Common Central Secretariat (Building 1, 2, 3), 137, Dr. Rajendra Prasad Road, New Delhi.



The recommendations of the Commission were in respect of improvement in ramps to the basement, sustainability aspects, camouflaging of services etc.

Layout and Building Plan Proposal in Respect of Redevelopment of Residential Colony for AIIMS At Ayur-Vigyan Nagar.



The revised proposal was in respect of expansion of AIIMS complex on either side of Auribindo Marg. The Commission considered the proposal in the context of the surroundings, design of entry gates, boundary walls etc.

Development/Redevelopment plans proposal in respect of proposed Executive Enclave (Block A) at plot no.36, 1 Dalhousie Road.



The recommendations of the Commission were in respect of improvement in sustainability aspects, camouflaging of services, lighting etc.

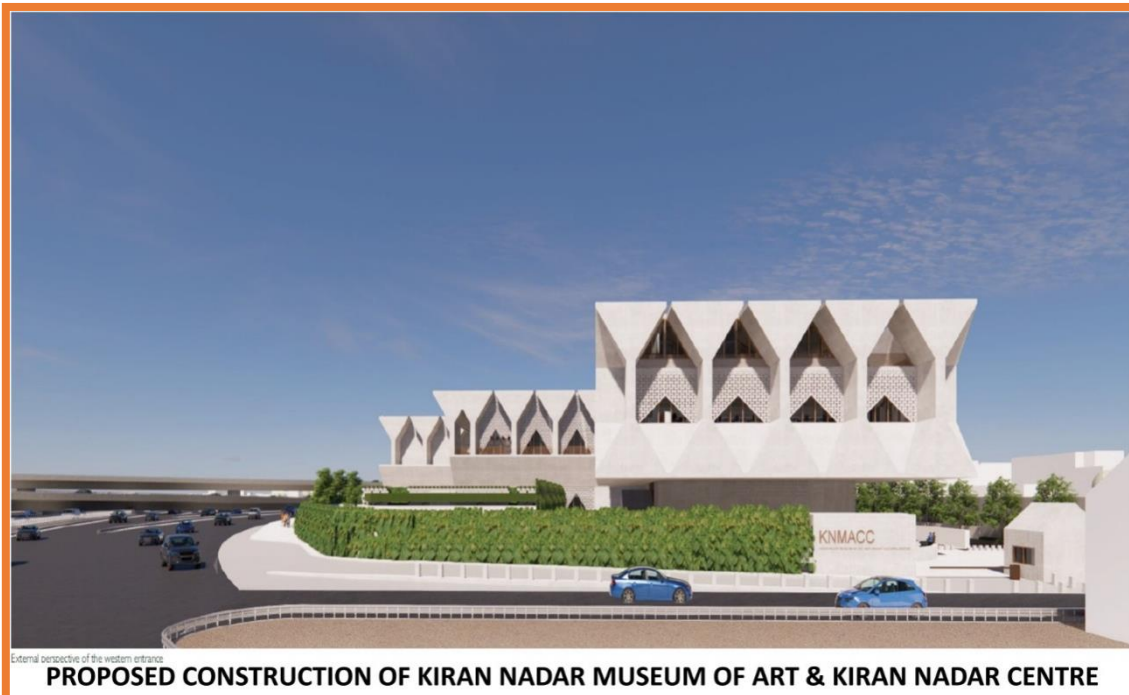
Development/Redevelopment plans proposal in respect of Proposed Executive Enclave (Block B) at plot no.38, 1 Kamraj Road.

The recommendations of the Commission were in respect of improvement in sustainability aspects, camouflaging of services, parking aspects etc.

Chapter III

Administration and Organization

Staff Position

The Secretariat of the Commission has a total strength of 29 officials. Secretary is Chief Executive Officer and is assisted by the Assistant Secretary (Tech.) for technical work and by the Administrative Division for administrative work.

The Secretariat of the Commission has also been entrusted with the added responsibility of functioning as the Secretariat of the Heritage Conservation Committee (HCC) which has been created in the year 2004 under the then Delhi Building Byelaws 1983 for the conservation of listed heritage buildings in Delhi. It is headed by the Additional Secretary in the Ministry of Urban Development, Government of India and the Secretary DUAC is the Member-Secretary of the Committee.

While the work of the Commission has increased considerably, the post of Urban Designer, Architect Planner and Deputy Architect which lapsed several years back are yet to be revived; thereby putting added responsibility on the existing officers and staff. Also, the post of Administrative Officer in the Commission was deemed to have abolished. Efforts are on for revival of the post. No new posts were created during the year.

The list of employees/consultants could be seen at Annexure–III.

Finance

DUAC is a non-commercial, non-earning body which functions in public interest. The Commission does not have any revenue generation of its own.

The entire financial requirement is non-plan in nature and is met by grant-in-aid from the Central Government.

For the year 2022-23 the Budget outlay (BE) of DUAC as approved by the Government was ₹450 lakhs and Revised Estimate (RE) was ₹548 lakhs. The total funds available including miscellaneous receipts, bank interests earned was ₹ 547 lakhs. Against this, the expenditure during the year was ₹ 541 lakhs.

The Commission had till the year 2011-12 been maintaining its Annual Accounts on accrual basis except for salary. As per advice of Audit, the salary component is also now being maintained on accrual basis from the year 2012-13.



Launching new issue of Kalakriti

Official Language Policy

With a view to encourage use of official language and provide a forum for the employees to express their creative talent, the Commission launched the next issue of its periodical titled 'Kalakriti'.

In terms of recommendations of the high-level Parliamentary Committee on Official Language on compliance of the provisions of the Official

Language Act by the Commission in its day-to-day functioning conducted in December 2016, active steps have been taken for implementation of the recommendations of the Committee and implementation report sent to the Ministry of Housing and Urban Affairs on all recommendations. With a view to increase the use of Hindi for official work, quarterly *Karyashalas* (Workshops) were arranged during the year. Besides the officers/employees of the Commission attended *Karyashalas* arranged by other organizations.

Vigilance Activities

The Secretary of the Commission functions as its Chief Vigilance Officer. In its day-to-day functioning, the Commission takes due care to observe the provisions of the vigilance manuals and other guidelines pertaining to purchases etc. brought out by the Central Vigilance Commission.

Several initiatives have been taken by the Commission to bring about greater transparency in its functioning.

During the year 2022-23 no case of corruption or any other vigilance matter was registered.

In terms of the guidelines prescribed by the Government, the Commission organized a Vigilance Awareness Week in the month of November 2022. The week started with the Pledge administered by the Chief Vigilance Officer to the other officers and staff of the Commission. Banners and posters on vigilance awareness were displayed, lectures organized on Conduct Rules and vigilance awareness in general.

Redressal of Public Grievances

The Commission has minimal direct dealing with the public. It receives very few grievances/complaints from the public. The scope for interaction with the public has further got reduced with the Commission having

adopted the Online Proposal Approval and Assessment System (OPAAS). However, Commission has appointed its Secretary as Nodal Officer for receiving complaints from the public and acknowledges the same. These are promptly disposed of in terms of the guidelines on the subject. The website of DUAC enumerates the system for redressal of public grievances.

Citizen's Charter

The Citizen's Charter of DUAC is available on its website (www.duac.org). It contains information as required to be displayed in terms of the Right to Information Act. The Citizen's Charter is reviewed periodically.

Right to Information

During the year under report the charge of Central Public Information Officer was held by the Private Secretary. Secretary of the Commission also acts as the First Appellate Authority for the purpose of RTI Act. During the year 2022-23 the Commission received 67 RTI applications. Of these replies were sent in all cases in time, 05 transferred to other organizations/Ministries as they did not concern DUAC. There were 18 number of First Appeal which were also disposed of in time. There was no second appeal.

Annexure-I

Criteria for Project Assessment and Approval

These criteria Project Assessment and Approval have been introduced with the objective of avoiding subjectivity while scrutinizing projects which are referred to DUAC for approval.

Through this system, all projects which are referred to the DUAC for approval are considered based on specific preset parameters. This is to ensure greater transparency, rationality, objectivity and accountability in the process.

Whenever any project is received by the DUAC for approval, the preliminary scrutiny is done by the technical staff of the Commission as per existing practice and put up to the Commission.

Subsequently, when the Chairman and Members of the Commission meet to consider approval of projects, they examine projects based on the following parameters:

Category		Parameter	Explanation
Urban Form / Context	1	Overall Space Planning and Massing	The overall layout of the area/building, space planning, distance between buildings, massing, heights, etc. shall be examined here from the point of view of harmony of the built masses.
	2	Skyline	Urban form of buildings shapes the skyline of the city. The effect of the building on the skyline shall be examined here.
	3	Street Picture	Buildings are part and parcel of the overall street picture. Buildings need to get harmoniously juxtaposed into the street picture presented to the eye of the beholder. The street picture shall be examined here.

	4	Views	Buildings need to be placed in such a manner so that the good views around are best made use of. Exploitation of views, both within the site and outside the site, shall be examined here.
Environmental considerations	5	Light and Ventilation	Specifically, the orientation, sizes of courts, ventilation, etc. shall be examined here from the point of view of ensuring maximum use of natural light and ventilation.
	6	Horticulture / Landscaping	The treatment of the exterior hard and soft open spaces, levels, plant materials (ground cover, shrubs, trees), rain water, etc. shall be examined here from both environmental as well as aesthetic point of view.
	7	Sustainability Features	Water harvesting, reuse, solar lighting, nature of materials used and various other 'green building' features shall be examined here.
Building Aesthetics	8	Exterior Finish	Building exterior finish treatment has a major bearing on city aesthetics. Here, the type of finishes being used shall be examined.
	9	Color	The exterior color finish of the building shall be examined.
	10	Method of Concealing Roof Top Equipments	Buildings often have several equipments on the roof top such as water tanks, generators, solar panels, plumbing and air-conditioning equipment's, etc. These present an unsightly picture and need to be concealed. Provisions for concealing these shall be examined.
	11	Method of Concealing Air Conditioning Equipments	Wall mounted air-conditioning equipment's are often an eyesore. These need to be concealed. Provisions for concealing these shall be examined here.
	12	Method of Concealing Pipes and other	Building has various services drain pipes, water pipes, etc. that are mounted along the exterior surface. The method of concealing

		Services	these shall be examined here.
	13	Boundary Wall	The boundary wall of a building is an important element which not only demarcates the plot boundary but also addresses the surroundings. The manner in which the boundary wall is designed has a bearing on city aesthetics. The design of the boundary wall and the manner it integrates into the surroundings shall be examined here.
	14	Public Art	Provisions for integration of public art into the building / layout shall be examined here.
	15	Signage	Signage provision shall be examined here.
Accessibility and Vehicular Parking	16	Vehicular Accessibility / Ease of Entry and Exit	The entry / exit to the site become very important in terms of location since ease of access, merging with traffic, etc. are affected. These issues shall be examined here.
	17	Pedestrian Accessibility and Movement	Pedestrian access into the site / building as well as within the site / between various buildings is very important. These issues shall be examined here.
	18	Parking	Proper vehicular parking is necessary, not just in terms of numbers prescribed (ECS) in the MPD, but also in terms of their location, positioning, workability etc. In some buildings, bus parking becomes important while in others, the drop off points become more important. All these aspects shall be examined here.
	19	Treatment of Entry	The entrance to the site / layout / building is very important from both the functional as well as the aesthetic point of view. The manner this has been articulated shall be examined here.
Any Other	20		Any other parameter that may be relevant to the specific project in question shall be examined here.
