



Notice Inviting Applications

Subject: Filling up the post of Chairman (Part-time) and 03 Members (Part-time) in Delhi Urban Art Commission (DUAC).

The Ministry of Housing & Urban Affairs proposes to appoint suitable persons as Chairman (Part-time) and Members (Part-time) in Delhi Urban Art Commission (DUAC), a statutory body under the Ministry. As per Section 4 of the DUAC Act, 1973, the Commission consists of a Chairman and such number of other members, being not less than two and not more than four as the Central Government may appoint from amongst persons, who, in the opinion of the Central Government, have sensibility and interest in the plastic and visual arts and urban development, or possess special knowledge or practical experience in the field of architecture or art. In terms of the provisions contained in Section 5 of the Act, the Chairman and the Members shall, unless their appointment is terminated earlier by the Central Government, hold office for a term of three years, from the date of their appointment. Further, the Chairman and the Members shall be eligible for re-appointment of that office, but only once.

2. Guidelines prescribed for appointment as Chairman and Member, DUAC are given below:
